Also, present were City Manager Jason Brown, and City Recorder Anona Yardley and Patty Simard. Public present were Sheriff Cody Black and Chief Deputy Kiley Maycock, and Jackie and Mark Whittlesey.

## **BEAVER COUNTY SHERIFF REPORT AND DISCUSSION:**

Sheriff Cody Black spoke with Council Members and informed them of traffic safety concerns that law enforcement has with youth and others driving ATV, side-by-sides, motorcycles, electric bikes and electric scooters. Current laws need to be revised and effective strategies updated to keep public safe. He also voiced safety concerns with the loitering, overnight camping occurring at public parks. Signs at the park will be updated.

### **CREDIT CARD FEES**

Anona presented a report to Council Members explaining the credit card service fees that are being assessed to the city for customers using a credit card for payments. There is a significant fee being charged. It was noted that because payment of utilities is being made, fees are assessed at a smaller rate. Utility customers that have utility bills above \$1500 a month are encouraged to pay with a check or an e-check on express bill pay and there will be a 3% convenience fee charge for all other credit card charges that are not paying for utilities.

Teresa Woods presented a report to Council Members showing CJC numbers from this past year, and recent trainings she has attended. Teresa indicated that the CJC in Beaver and Garfield will not be under the direction of Iron County anymore. She indicated that this is a positive split. Teresa will be the director over Beaver and Garfield Counties Centers. Teresa reported that the State has legislated some funding that will currently cover her position and basic expenses. Teresa asked if Beaver City would be willing to sponsor the CJC with their Golf Fundraiser again. Council support was given in allowing them to use the golf course and carts at no cost to the CJC. This fundraiser will be held August 4.

Jason presented a power point reviewing April's financial statement with council. The electrical fund balance is a concern due to increase in the power purchase costs.
